2019 MA 4-H Agricultural Day Speech Contest



Purpose

The purpose of this contest is to promote a stronger interest and clearer understanding of the many aspects of agriculture. The winner will present their speech at MA Ag Day at the MA State House in Boston on March 27, 2019. Speaking at Ag Day provides the opportunity for our youth to gain knowledge, appreciation, and understanding of agriculture, to promote agriculture's many values and virtues in the Commonwealth and to inform others about the educational opportunities in 4-H.

Application Process

Based on the number of applicants, one or two contest sites will be set-up in the state. The contest(s) will be held in February. Subject

Contestants may choose any subject pertaining to agriculture in Massachusetts and how 4-H relates to agriculture. Current policies, affairs and trends in the industry are suitable topics.

Time Limit

The presentation should be five minutes in length. Each contestant will be allowed five minutes in which the judging committee will ask questions relating to his or her speech. Deductions will be made from the score of each judge for speeches that are under the time limit or over the time limit in length.

Rules

- Contestant must me a currently enrolled 4-H member age 14-18 years old as of 1/1/19. Applicant must be a 4-H Ambassador and/or MA 4-H Dairy Ambassador member.
- Speaking order will be randomly drawn by event officials. The event officials will introduce each
 participant by name and in order of the drawing.
- A contestant will be permitted to use notes while speaking, but deductions in scoring may be made for this practice if it detracts from the effectiveness of the presentation.

A timekeeper shall be designated who will record the time of each speech, noting under time or overtime, if any, for which deductions will be made.

A maximum of five minutes will be allotted at the completion of speech for judges to ask questions. Each contestant will repeat the judge's question. Each contestant will be scored on his or her ability to answer questions by all judges.

*When all contestants have finished speaking, each judge will total their scores for each speech. The combination of the judges' scores will determine the final placings.

Time Deductions (-20)

Contestants will receive a 30 second grace period over or under the allotted time before deductions are taken. Any time over/under 31 to 45 seconds will receive a 10-point deduction. Any time over/under 46 to 60 seconds will receive a 20 point deduction
